On 9/5/13 at about 1100 hours I was working as the School Resource
Officer at Arapahoe High School at 2201 E. Dry Creek Rd.

Assistant Principal Kevin Kolasa told me about an incident that

happened on Tuesday 9/3/13 at about 1445 hours.

He told me that teacher Mark Loptien was in the east parking lot of the school. He said Mr. Loptien heard 12th grade student Karl Pierson [REDACTED] yell something like "I'm gonna kill that guy!" Mr. Loptien heard Karl yell this from across the parking lot.

On 9/4/13, Mr. Loptien asked Assistant Principal Darrell Meredith if any students had been suspended the day before. Mr. Meredith determined that Karl had just had a meeting with the school librarian Tracy Murphy who also runs the speech and debate team. It was learned that Mr. Murphy had just had a meeting with Karl and his mother. During the meeting Karl was demoted from being a captain on the team (Karl was still on the team).

Mr. Kolasa said that Mr. Murphy didn't hear the comment but another teacher told him Karl made the comment.

Mr. Kolasa said he spoke to Karl's mother Barbara Pierson. She said she was going to keep Karl out of school for the next two days and return Monday 9/9/13.

I spoke to Mr. Loptien. He told me that he was across the parking lot when he heard Karl yell the comment. He could see that Karl was with his mother and another female student whom Mr. Loptien thought was [REDACTED]. Mr. Loptien could also hear Karl yell other profanities like "fuck" and some other words he couldn't understand.

I spoke to Mr. Murphy. He told me that he did demote Karl from being a captain on the speech and debate team because he has said some things in the past that he didn't think made him a good captain. Mr. Murphy said he was concerned because Karl does have a temper. I told Mr. Murphy if anything happens in the future with Karl to let me know.

Mr. Kolasa is going to have a re-entry meeting with Karl and his mother on 9/9/13.
