SYNOPSIS:

On Wednesday, December 18, 2013, at approximately 7:45am, I, Colorado Bureau of Investigation (CBI) Agent TAMMY LEE, arrived at Arapahoe High School (AHS), which was located at 2201 East Dry Creek Road in Centennial, Colorado. The purpose of responding to AHS was to assist with interviewing the school staff who possibly had information regarding the recent school shooting.

ACTION TAKEN:

On Wednesday, December 18, 2013, at approximately 7:45am, I, Colorado Bureau of Investigation (CBI) Agent TAMMY LEE, arrived at Arapahoe High School (AHS), which was located at 2201 East Dry Creek Road in Centennial, Colorado. The purpose of responding to AHS was to assist with interviewing the school staff who possibly had information regarding the recent school shooting. Upon arrival, law enforcement members from the CBI, Federal Bureau of Investigation (FBI), and Arapahoe County Sheriff's Office (ACSO) were notified that the teaching and administrative staff had planned to meet at the school from 9:00am until 1:00pm. It was also made evident through the school board members present at the high school that they were very upset law enforcement was present to speak with staff as they had not been notified we were going to be there.

It was later determined by the school board that law enforcement should not be in the hallways or cafeteria of the school, but rather in the theatre/auditorium of the school. We were informed the school administrators would tell the school staff to "touch base" with law enforcement in the theatre/auditorium if they wanted to.

It should be noted that no members of the teaching staff or administrators came to the theatre/auditorium that day to be interviewed. At approximately 1:30pm, law enforcement officers left the school.
